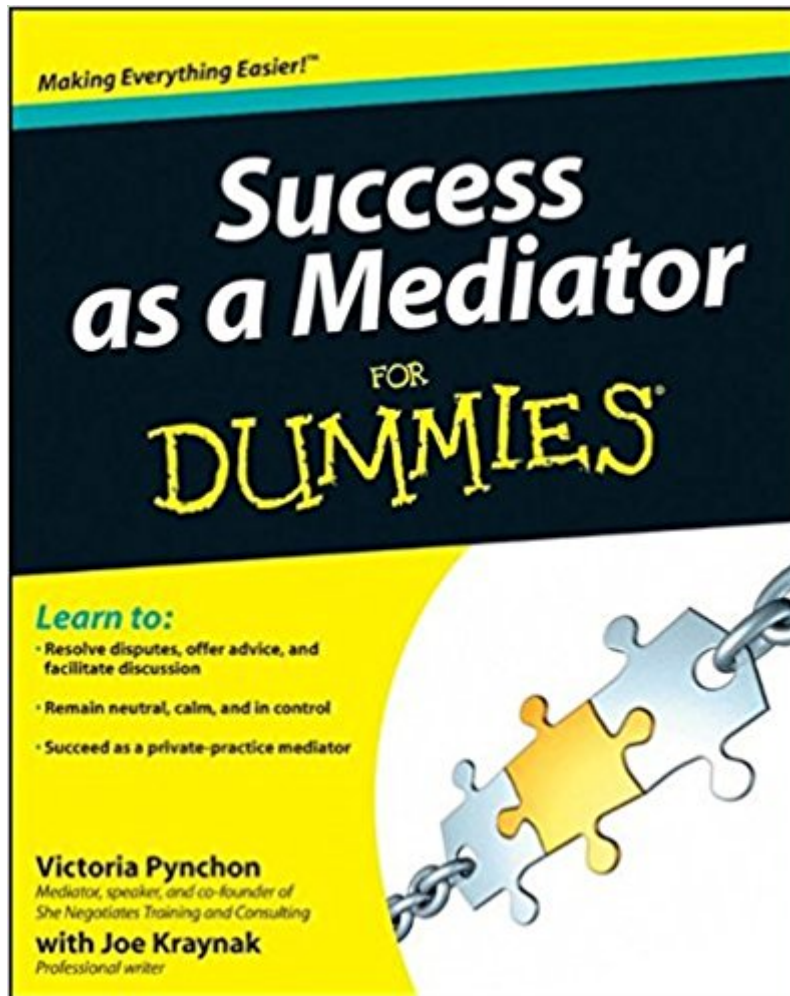

While the satisfaction of helping people resolve their disputes will be a reward in itself, I would like to make this a larger part of my construction counseling practice. Vickie's new book gives great practical advice on everything from various techniques of mediation (facilitative, evaluative and the like) to ways to make money as a mediator. Where her prior book gave great anecdotes and stories to illustrate conflict resolution in a more general sense, her new "Dummies" book is focused exclusively on the practice of mediation. Like the other books in the "Dummies" series, it starts with a great overview and outline of the various chapters and moves forward in a manner that allows a reader like me to read it cover to cover or to find just what I'm looking for. As a newly minted mediator, the book gives me a great perspective on the future possibilities as well as giving real life ideas that I may not have thought of. I recommend it for anyone dipping a toe into the mediator pool. That's not to say that I don't think it will help the seasoned mediator (or litigator for that matter). Many of the tips point out impasse breaking

strategies aside from locking the parties in a room until they agree. Many of these tips give some great "outside the box" ideas to get the most recalcitrant parties to see the value of a settlement. The more "arrows" in the quiver of any mediator (new or old), the better in my thinking. In short, if you are at all interested in mediation from either the advocate's or the mediator's perspective there is something in this book that will help you out.

After I read this, I decided to not go into Mediation as a second career. That's why these books are great - they give you all of the facts.

I am not a mediator and have no interest in pursuing this as a career - however I found the book to be a tremendous resource for anyone even mildly interested in conflict resolution. And let's face it: every one of us has situations day to day or just one-off big moments when we need to approach something as a mediator would to resolve a dispute (or perhaps we're one of the parties involved in the dispute). The advice is practical and there are examples from current affairs such as lessons from Occupy Wall Street, which makes it contemporary. The book provides a thorough background on the causes of conflict (differences in perception, beliefs and values) etc and how to use certain skills such as persuasion to work through disputes. Overall an extraordinarily well-written book which is a must have for anyone's bookshelf - you never know when you'll need it.
